## Sanctuary Judge Sets Convicted Felon Free. He Immediately Attacks Grandmother at Gas Station.

But wait, it gets worse. When that carjacking failed, Reyes tried hijacking a big rig truck. He stole the driver's phone first. Then he attacked a woman in her 60s at a gas station. She was just trying to pump gas! The brave grandmother fought back by dousing him with gasoline.

Police say it began when Reyes called 911 to report a woman screaming in a vacant house next to where he had been staying. Officers responded and noted a broken window and cuts on Reyes' hands.
